2. Each cabin must have at least one passenger 21 years of age or older with a valid driver's license and major credit card. All United States passengers need proof of citizenship and photo I.D. (Passport, birth certificate or copy of birth certificate with raised seal.) Resident Aliens need an Alien Resident Card, valid passport, photo I.D. and a valid U.S. Multiple Re-entry Visa. Resident Aliens and Aliens must contact the appropriate consulate to inquire about necessary travel documentation.
